MESSAGE FROM SHERIFF HERNANDEZ

Last month I shared information with you about some of the challenges we're facing as we run your Travis County Jail in these unprecedented times. I'd like to take this opportunity to expound on the plight of the people in our jail population who are struggling with mental illness. Nearly 40% of inmates in our custody are battling some form of mental illness. 27% of them are diagnosed with moderate to severe symptoms. This includes symptoms such as psychosis, suicide ideation, delusions and manic or depressive mood.

One of the impacts on our jail population is a backup of people who have been deemed mentally incompetent to stand trial, waiting for admittance to a hospital. The state hospital system has put a limit on admittances, and the number of inmates in our custody who are waiting has significantly increased. These inmates have high mental health needs and wait up to two years to be transferred to a hospital.

Can you imagine being locked in a jail cell because you committed a crime based solely on mental illness? Many of these inmates don't know where they are or why they're there. They languish in a county jail, waiting longer for court ordered hospital treatment than they would have stayed in jail if found guilty of the offense they committed. This is a travesty!

We work closely with Integral Care and NAMI Central Texas (National Alliance on Mental Illness) for assistance in caring for this vulnerable population. Our team of mental health professionals works tirelessly to offer the very best care to these inmates. But let's be clear. A jail is not a hospital.



It isn't designed to provide the kind of environment suited for acute mental health treatment. We need to do better, and I hope our state will step up during the next legislative session.

COBRA GRADUATION # 103



The TCSO Training Academy offers a Corrections Officers Basic Recruit Academy (COBRA) for all new-hire Corrections Officers. Corrections Officers attend the COBRA course while on-duty within their first year of employment; Texas Commission on Law Enforcement (TCOLE) provides a one year, temporary Corrections Officer license. COBRA is 360 hours of specialized instruction that consists of the following:

- PHASE 1: Course satisfies TCOLE requirements for the Basic County Corrections course; topics include booking,
- identification, inmate rights, head-counts, emergency procedures, searches, classifications, health services, etc. PHASE 2: Course highlights those areas that are fundamental to normal and emergency operations of the Travis County Correctional system; topics include defensive tactics, firearms training, CPR, smoke-house safety, departmental policies, interpersonal communication, wellness, etc.

TCSO Central Warrants are essential personnel who provide 24/7/365 advanced level support to law enforcement, criminal justice agencies and the general public. In accordance with FBI and Texas Department of Public Safety (DPS) policies, as well as federal and state statutes, Warrants monitors, maintains, operates and relays information via state and federal (TLETS/NLETS) telecommunication network systems. To maintain that advanced level of support, our staff research, identify, enter and maintain felony and misdemeanor arrest warrants as well as protective orders within state and federal law enforcement databases.

Warrants also provides entry and information on Condition of Bonds, missing persons and stolen property. All staff must maintain the required level of certification via the vigorous testing system created and maintained at/ by the DPS. We're proud to recognize our dedicated and hard-working staff who provide an exceptional level of service everyday.
